The Vision 2030 Jamaica Secretariat is currently compiling a Performance/Progress Report on Medium Term Socio-Economic Policy Framework (MTF) 2015-2018. While the report specifically covers the fiscal year 2016/17, it gives focus to performance/progress to date under the MTF. The attached Reporting Guide and Table of Priority Strategies and Actions are to be utilized in completing agency/organizational reports as it relates to the area of "Population" under National Outcome #1 "A Healthy and Stable Population".

The report is to be completed over the three week period - July 25, 2017 to August 14, 2017 - and submitted via return email on August 14, 2017. Please note that the MTF Performance/Progress Report is to be submitted to Cabinet by mid September 2017 and so it is imperative that the reports are submitted by the stipulated deadline. If you are unable to meet the deadline, please indicate so as soon as possible.

Also, the next quarterly meeting of the Population Thematic Working Group (TWG) will be held on September 8, 2017 and will take the form of a Performance/Progress Reporting Workshop. The focus will be on examining the draft report for the area of "Population", including presentations from key stakeholders and an examination of gaps and challenges to development as well as the key accelerators for development. Attention will be given to performance under relevant Sustainable Development Goal (SDG) targets.
